- An experienced Burial at Sea Company supporting National & Independent Funeral Directors.
- All operational /logistical aspects of a Burials at Sea - from death notification to burial at sea.
- The MMO Licence and all paper work for your clients Sea Burial.
- Subcontractor support - assuming full responsibility for compliance with the MMO Licence
- All logistical matters on the day of burial included
- The delivery of your client's final wishes to be buried at sea.

FUNERAL DIRECTORS' ROLE – FOLLOWING NOTIFICATION OF THE DEATH

- Funeral option required a sea burial – commence your “normal” professional arrangements
- Appoint Mamarine.com Llp to act for licensing and delivery of the burial at sea
- Obtain a MMO specification sea casket (J C Atkinson 0191 415 8921)
- All normal FD's duties including preparing the deceased for a sea burial (no embalming)
- Forward (via email) copies of the following Certificate:

DEATH CERTIFICATE

FREEDOM FROM FEVER & INFECTION CERTIFICATE

CORONERS OUT OF ENGLAND CERTIFICATE

(Retain the originals of these document for inspection on the burial day)

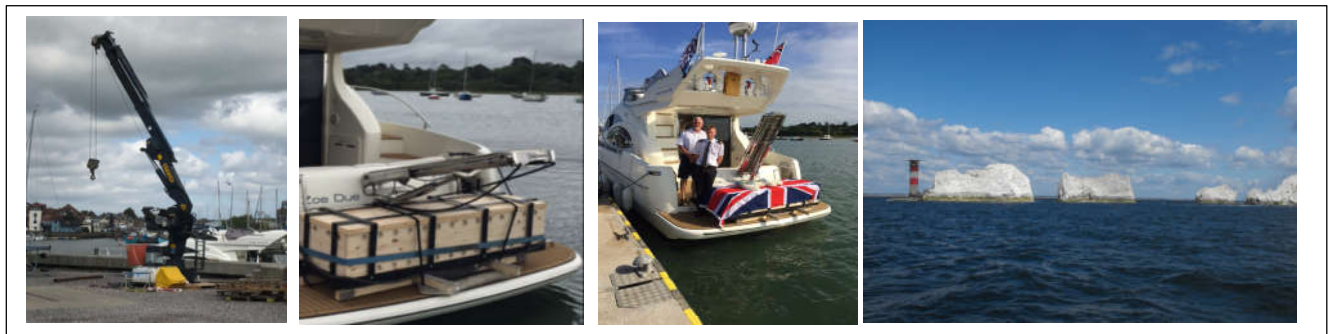
MAMARINE.COM LLP (BURIALS AT SEA.CO.UK) - ROLES AND RESPONSIBILITIES

- On receipt by us of these documents (via email) - Marine Management Organisations (MMO) online process of obtaining the Licence for your client's sea burial (licence fee is payable at application)
- Once the License is granted (usually at the end of the online process) we advise the Funeral Director
- Liaising - Funeral Director and Weather forecasting to find best dates
- Simultaneously all logistical arrangements confirmed (Boat/Crew, Crane, Harbour Master)
- Assertion Family/Friends wishing to accompany aboard the deceased on their final journey (Up to 10 passengers)
Additional passenger capacity can be arranged by using added vessels
- We seek to “tailor” the burial with the family –Priest, Minister or family member speaking?
- Once a date/time has been agreed - MMO will be notified of the burial date
- We will raise our invoice which should be settled prior the boat putting to sea
- Burial day - liaise with Funeral Director, Family Member, Mayflower Hotel, Harbour Authorities and MMO
- Following the Burial at Sea we complete the MMO Licence compliance confirming



BURIAL AT SEA DAY - FUNERAL DIRECTOR

The Funeral Director should deliver the deceased in the MMO specified casket to the dockyard for the crane to place the casket aboard our vessel for the burial at Sea. Collect Family from Mayflower Hotel & escort to Harbour Masters pontoon. MMO have the right to inspect the casket and documents prior to the vessel departing the Harbour Masters Pontoon



WE ASSUME FULL RESPONSIBILITY FOR CARRYING OUT THE MMO LICENCE REQUIREMENTS ONCE THE CASKET HAS ARRIVED AT THE CRANE AND THE CASKET HAS BEEN PLACED ABOARD OUR CHOSEN VESSEL
